DON PEDRO GODINO MARTÍN, ALCALDE-PRESIDENTE DEL AYUNTAMIENTO DE GAUCÍN,
Let it be known that:

1. Continuing one of the oldest and most traditional local festivals, and having obtained the necessary permits, next Sunday April 17 is the day of the Bull Run.
2. The schedule of the event will be from 10.30 to 11.30hrs, from 12.00 to 13.00hrs, from 16.00 to 17.00hrs and from 17:30hrs to 18:30 hrs and the route will include the streets of Convento (formerly L. Armiñán), Santo Niño (formerly José Antonio), Guzmán el Bueno (previously Calvo Sotelo), Nueva (formerly Mártires), Los Bancos (formerly Queipo de Llano), San Juan de Dios (Corral) and Barrio Alto.
3. The fenced area serves only to define the route and facilitate the running of the bulls. During the course of the event, given the nature of the bulls, please be aware of the danger both inside and outside of the defined route.
4. Direct participation in the event involves a risk. This risk is freely and voluntarily assumed by direct participants so that neither the Council nor the Organizing Committee is responsible for any damage from incidents arising as a result of the event. For this purpose those people that remain on the streets comprising the route and its peripheries are considered to be direct participants.
5. In order to ensure, as far as is practicable, the safety of people and property, and to avoid unnecessary suffering to the animals during the event, participants must comply with the following regulations:

REGULATIONS

- The streets of the village comprising the route of the event must be cleared of vehicles and any objects or goods susceptible to damage, or capable of causing damage to participants.
- From 07:00hrs to 19:30 hrs, vehicles are prohibited in the streets comprising the route.
- The streets comprising the route are considered 'out of bounds' to minors and those that do not wish to participate actively in the event, as well as those who, as a result of inebriation, physical disability or any other circumstances, are deemed unsuitable participants.
- The rope that holds the bulls will be under the control of members of the cultural association "La Cuerda", which will be clearly identified.
- It is strictly prohibited to place on the route bottles, glasses or other objects that could impede and/or injure participants.
- During the time frame of the celebration of the bull festival, loud music will be prohibited along the itinerary and surrounding areas.
- Participants must not hang from railings and balconies in excessive numbers as this could endanger the safety of themselves and others, nor must they over-crowd or congregate in areas that would prevent or hinder the ability of other participants to move to safety.
- Those directly involved in the event are advised to dress in clothing and footwear that will allow the greatest possible freedom of movement.
- Participants are prohibited from hitting or riding bulls, and from holding the bulls' tails, as well as any action that may lead to abuse or suffering of the bulls.
- An emergency/first aid station with the services of medical personnel, ambulance, etc., available to treat participants who suffer illness or injury, will be located in the Guadalinfo building in Paseo Ana Toval.

In any case, participants must, at all times, follow instructions given by the Local Police, Civil Protection or event organisers.
